Dear Madame/Sir:

The FBI Portland Field Office threatened and intimidated, Belinda D. Jackson, as I tried to report Criminal Misconduct and new information on June 5, 2003, concerning the May 23, 2003, Press Release by the Washington Headquarters of the FBI; concerning my May 2002 OPR complaint. I have been in communication with the OPR branch of the Bureau and feel a third party (FBI Special Agents) have obstructed and manipulated my letters. On April 14, 2003, I brought this to the attention of Special Agent In Charge Charles Matthews a letter requesting verification of OPR staff I believe are frauds. Spec. Agent In Charge Matthews relegated the response to **my letter** to Bill Treceder, General Council. I was instructed of this by Mr. Treceder, **I at no time** have I spoke with Spec. Agent Matthews about this issue. **Needless to say, (because I expected it)** Mr. Treceder **refused** to answer my questions and **referred me** back to SAC Charles Matthews but by May 30, 2003, **SAC Matthew was retired, so I have been informed.**

June 5, 2003, I went to the Portland Field Office of the FBI and was accosted and threatened by three individuals whom claimed to be FBI Spec. Agents of the three only one would reveal his identity and I'm not sure he was telling the truth. I asked to see his badge and he opened in closed it in a blink. I was threatened with arrest if I did not leave the premises. I asked why and he was told by the individual whom described himself as the duty person because my complaint was filed and I can't come to the office ever again. I then explained to all three Mr. Bill Treceder's letter on May 16, 2003, doesn't bar me from contacting this office and I was threatened with arrest. I told Spec. Agent Klingard after I was threaten to arrest he took out his hand-cuff and did nothing but threaten. I was forced on to an elevator and told if I ever returned I would be arrested. I then went directly to the US Attorney and asked to speak with the US Attorney Duty of the day person. The person whom appeared just happens to be mention on my May 2002 US DOJ Inspector General Complaint, he's, Charles W. Stuckey, and I believe he is participating in Conspiracy and Obstruction. I told him what happened at the FBI field Office and demanded something be done concerning this threat of arrest and intimidation and he said "I am not doing anything because it wouldn't have any value" I ask him to explain but he just mumbled and looked like a confused idiot. I am demanding action right away the fact this travesty happen right on FBI premises and these three individuals attempted to laugh off there actions as if it wasn't illegal. I requested a written letter detailing the action of June 5, 2003 and Spec. Agent Klingard, refused and then he laughed in my face as if he was attempting to incite conflict. I left a message with the US Attorneys' Receptionist at the Department of Justice as well as demanding US Atty. Charles Stuckey to inform the US Attorney of the tragic ordeal.

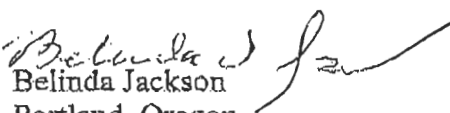

I am contacting your office because I have evidence which proves a US DOJ Agency is participating in Criminal Misconduct. I have given the Portland Office of The FBI ample opportunity to assist me and provide resolution too my charges of Obstruction Of Justice, Intimidation, Fraud, and a host of other infractions. ~~The entire time has been spent attempting to deter my request participating in deceptive practices and harm.~~ I am demanding The US Attorney alert the US DOJ office of Inspector General as well as FBI officials of this devastating harm. Enclosed find three documents: 2 fraudulent letters from the Office of Professional Responsibility in Washington DC, and a Summons and Complaint which was manipulated and used to obstruct a US District Court Law Suit.

US Attorney Immergut, I have been threaten with arrest and banned from ever contacting ~~with~~ the Portland FBI office this threat was committed twice once by William Treceder and the other was Spec. Agent Gonzales, (whom informed me upon our first meeting he only handles violent crimes for the FBI. I donot know why this was relevant since I never requested his presence.) I also sent a registered letter to Spec. Agent in Charge, Robert Jordan, concerning the treatment and harm I have endured and was met with deception and harassment. The Registered Letter was mailed on Dec. 30, 2003, when I was thrown out of the Office by Spec. Agent Gonzalez, Threaten with arrested and told never to come back again. I am contacting you the US Attorney because I feel this is criminal behavior by a Federal Agency and my effort to report this crime has and continues to be Obstructed.

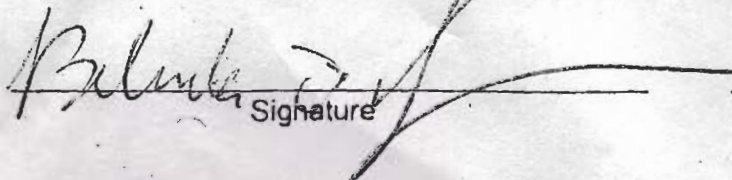

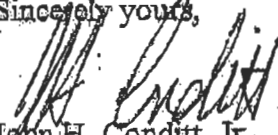
Dear Ms. Jackson:

Your letter to the Attorney General, dated October 10, 2000, was forwarded to the Federal Bureau of Investigation's (FBI), Office of Professional Responsibility (OPR). OPR is the FBI entity responsible for investigating allegations of serious misconduct or criminal activity on the part of FBI employees.

In your letter, you alleged that Special Agents (SAs) in the Portland and Los Angeles Divisions of the FBI committed criminal acts to include obstruction of justice, conspiracy, collusion, and harassment. You further advised, the Los Angeles Division, FBI refused to accept evidence you provided which proved that your personal bank account was being manipulated. You added that you met with the same circumstances when you moved to Oregon and approached FBI SAs in the Portland Division.

OPR gives serious and appropriate attention to all allegations of FBI employee misconduct. Such allegations are taken seriously by OPR, and I can assure you that this matter will receive appropriate attention. Thank you for bringing this matter to my attention.

RE: Formal Complaint Against Senator Ron Wyden, DEM Oregon

Honorable Senator George V. Voinovich,

I am filing a formal complaint with the Select Committee on Ethics because I have ~~proof~~^{proof} a member of the US Senate has participated in Fraud, Breach of Trust, Conspiracy, and Obstruction. The member is Senator Ron Wyden, dem of Oregon. I am sending with my complaint copies of document that support my charge. The letters are from the Senator Office and are signed by his staff. I

In early 1998 I contacted Senator Wyden office with evidence proving the US Attorney in Oregon as well as the local FBI field office had engage in a cover-up to hide criminal action by US Treasury Department Employees. The Criminal Action is as follows: Fraud, Harassment and Intimidation (this includes physical harm), Illegal Production of Federal Agency letters (IRS, EEOC, and US District Court of California, and US Dept. of Education), US Postal Mail Theft and manipulation , Criminal Interference with the process of a State Agency, and Violation of Constitutional and Bill of Rights laws . The US Attorney (Kris Olson and Michael Moseman) stated no one Body of Government has Jurisdiction over Criminal Action over the FBI and they can do what ever they want. I have placed the letter which supports this with my Complaint labeled (Proof 1) and Senator Wydens Office confirm the US Attorney's position and threaten me with arrest if I contacted the Senator Office again.

I never believe The US Attorneys' letter (Proof 1) and contacted several other representative whom have subsequently been given erroneous information. All my attempts too receive help have been obstructed by a third party; I feel it is initiated by the Portland Oregon FBI Field office which have flat out lied and attempted to create an atmosphere Rage and Violence. Research has uncovered the Crime Bill Act of 1994, which gives the US Department of Justice the jurisdiction to investigate a pattern of misconduct by any law enforcement entity. This information has been presented to Senator Wydens' Office as well as US Attorney Michael Moseman they have ignored my pleas for help and I have been harmed both emotionally and physical in the hopes of ~~being~~ my demand for Justice.

This week a local Newspaper printed a story which horrified me, Senator Wyden had put forth US Attorney Michael Moseman, name in for a Judgeship. This is a blatant pay-off, US Attorney Michael Moseman, was informed and 2001 of Senator Wydens' Office behavior and the lies and threats they made if I continue to contact his Office. I believe the Select Committee on Ethics should Expel Senator Wyden and block his nomination of US Attorney Michael Moseman. The proof is labeled and attached to my letter as well as proof that proves as of May 08, 2003, FBI employees have continued to cover-up criminal action as well as target and cause irreparable harm to me. The charges I have documented in this letter have never been investigated and the US Department of Justice has stated they do not have jurisdiction (Proof 2). Please help me, this is turning into one pay-off after another and I have proof.
